Application Instructions

Applicants should complete application and submit to GBA, 50 Hurt Plaza, SE, Suite 1050, Atlanta, GA 30303, or email to kfriestad@gabankers.com. Tuition may be paid by: 1) Check (made payable to the Georgia Bankers Association); 2) Credit card (MC, VISA, or AMEX); or 3) Invoice – request below. **Applications must be submitted by March 28, 2018 to guarantee a hotel room. Applications submitted between March 29 and the application deadline of April 20 are welcome but we cannot guarantee a hotel room.** Tuition must be paid in full by April 20. Admission Requirements

- For admission, a student must meet the following requirements:
- Be employed as an officer or key staff member of a bank, or a GBA Associate Member
 - Be involved in bank compliance or have three years banking experience
 - Be recommended by the bank's CEO or senior management.

If the applicant does not meet one of the above requirements, but the nominating officer feels the candidate is qualified, a letter from the CEO may be sent with the application explaining the circumstances for review by the Board of Directors.

Tuition Inclusions and Schedule

School tuition is \$2,150. **Applicants may register and pay by Feb. 9, 2018 to receive early tuition of \$2,020.** Tuition includes: All instruction; supplemental materials; double occupancy accommodations for Sunday-Thursday nights at the UGA Hotel; daily breakfast and lunch; Welcome Barbecue on Sunday, May 6; and daily refreshment breaks. Overnight parking in the UGA Conference Center Hotel deck is included with your hotel room. Students may request a private (single) room for a \$385 flat surcharge. Students changing room types onsite will be responsible for any increase in room charges resulting from this change.
